Email from Guy on October 29, 2022: Guy has submitted a <u>formal notice</u> that he is spearheading an initiative to have neighbours register a restrictive covenant on their land titles to only allow single family dwellings. Guy will excuse himself from any discussions regarding this initiative. He is to follow direction from the community <u>survey results</u> when representing the community association in City of Calgary Heritage LAP Planning discussions.

Presentation from IBI and Lindsay Hills Northwest Healthcare Properties & Samuel Alatorre from IBI Group regarding land use change.

- <u>Draft Direct Control District</u>
- No change on existing building (height, scale, profile, etc.)
- No imminent plan for surface lot development but eventually may be developed.
- Question from Guy: Would you be prepared to conduct an open house for community members?
 - Should be able to be accommodated. Haven't done yet because of uncertainty of in person public engagement since covid.
 - Should be done ASAP as we are working within a tight timeline (~180 day from start to approval)
- Question from Guy: When to get to council?
 - o Q1 2023.
- Question from Hanita & Chris Simard: Potential for buildings to be built higher if DC land use is approved potentially from new ownership?
 - Any further increase in land use would need to be re-applied by any new owner of land.
 - Heritage LAP draft allows for higher building heights than what is being proposed.
 - There are no land use districts that allow for overnight stays except for DC, that is why they are requesting DC.
- Question from Chris Doyle: Why is the surface lot included if it is not intended to be developed.
 - Not intended to be developed immediately. Could be developed in the future.
 - Parkade isn't in the plans for future development.
- Question from Harry: Has a traffic study been completed?
 - o Hasn't been completed but would be completed if it was required by the city.

- Presentation
 - Summary of Concerns
 - 1. Misrepresentation of the Community by the CA apartment residents are under-represented, concerned that third party survey conducted through Stone Olafson was biased
 - 2. CKE's needs are not being served by the CA declining school enrolment, concerns of N Kelvin Grove in LAP (multi-family units in Neighbourhood Flex, Connector and Commercial Corridors areas that would potentially increase building height from 3-5 stories to up to 26 stories)
 - 3. Clarification on duties of the CA and PD How is the CA working with the City? How is the CA keeping residents informed on planning developments? What is the work being done to address our declining population and school viability?
 - calls for CA to take a position on LAP
 - o concerned that CA focused on majority rule, rather than represent of all residents
 - conflict of interest with PD and spearheading RC (in opposition to the LAP)

General Discussion:

- Sonja: Was there a way to deter people from outside the community from responding to the survey? **Action:** Guy to check and provide.
- Sonja: What efforts has the board given to distribute information regarding the Heritage LAP. E newsletter, information sessions etc.
